Policies and Procedures Release Form 2010-2011:

I, _____, parent or legal guardian of _____, a student enrolled in classes with The Pointe School of Dance, Inc. (hereinafter referred to as, The Pointe) state and agree as follows:

a. I understand that the activities in which my child is enrolling may involve certain risks or hazards to my child, including the risk of accident or physical injury, and I do not believe these activities will pose any undue risk or hazard to my child.

b. I understand that hands-on instruction and spotting is used for safety and/or advancement of students and I will notify a supervisor if this is a problem for my child or me.

c. My child is in good physical health, and suffers from no conditions or diseases, which would or could render my child more susceptible to injury or illness as a result of the activities in which my child will be participating at The Pointe.

d. In consideration for acceptance of my child as a student at The Pointe, I, the undersigned, on behalf of myself, my child, personal representatives by these presents remise, release, forever discharge and indemnify, and hold harmless The Pointe, its owners, directors, agents and employees from and against any and all manner of action or actions, suits arising out of or in any way associated with my child's participation in dance instruction, recitals, rehearsals, etc. sponsored by The Pointe.

e. I understand that pictures and videos taken of students at The Pointe may be used in The Pointe advertisements and/or instructional material and/or The Pointe website.

f. I further acknowledge and agree to pay for all fees and charges made by The Pointe in connection with services provided by The Pointe to my child. I understand: A once per year non-refundable REGISTRATION FEE of \$10.00 will be charged to each family upon registration. Tuition is due on the 1st of every month. Payments not received by the 7th of each month will be considered late. A \$5.00 LATE FEE will be applied to your account on the 8th as well as every week after until payment is received in full. There is a \$20.00 FEE ON ALL RETURNED CHECKS, and there are NO REFUNDS on classes or fees.

g. Recital costumes will be paid for in 4 payments of 25% each. The first 25% is due upon enrollment. The second 25% is due with November tuition. These two payments are fully refundable until Thursday, December 16th, 2010. The third payment is due with January tuition and final 25% is due with March Tuition. After December 16th all costume payments are non-refundable.

h. If your child will no longer be attending The Pointe, we must be notified in writing and you will be responsible for all charges on your account up to that point. Messages and/or not showing up for class anymore are NOT acceptable forms of cancellation. Your account will continue to incur charges (tuition, late fees, costume fees etc.) until we have received written notification.

Other:

- Classes are closed to all visitors unless otherwise notified.
- Dancers are to wear dancewear, tights, & shoes with their hair secured off their face.
- No Gum, Candy, or Food of any kind is allowed.
- The Pointe is not responsible for lost or stolen items. Please label all items with your dancer's name.
- All parents are encouraged to escort their children all the way in and out of the studio. Students under the age of 10 will not be allowed to leave the studio without an adult.
- The Pointe is not responsible for providing before or after class care for students.
- Please call ahead of time if your dancer will not be at class. 620-728-0060
